


Urban Parks are Landscape Infrastructure



Woodland, meadow, and aquatic plants interact vigorously in the ongoing process of renewal on the former brownfield site at Corktown Common, designed by MVVA.




Corktown Common MMVA, Toronto

Corktown Common park is a vital piece of urban infrastructure, designed as a **flood protection landform** that elevates the terrain to safeguard the West Don Lands from the Don River flooding.

All stormwater is managed on-site and re-used for irrigation and splash pads, and the site offers a beautiful space for citizens to find respite, socialize, and appreciate nature.

Topography protects the West Don Lands from flooding by establishing two conditions: a wet side designed to absorb and manage flooding, and a dry side that remains elevated and protected.

"Recreation Infrastructure Renewal


While Budget 2025 does not yet include a dedicated stream for recreation infrastructure, CPRA is encouraged by the government's plan to launch the Build Communities Strong Fund—ongoing funding to support community infrastructure through Housing, Infrastructure and Communities Canada.


CPRA continues to recommend a dedicated Recreation Infrastructure Renewal Program—\$100 million per year—to modernize arenas, pools, community centres, and parks that are essential to health, safety, inclusion, and local economies."
